2 Carbon Pricing (Amendment) Bill – read a second time and committed to a Committee of the whole House.

The House immediately resolved itself into a Committee on the Bill – (Minister for Sustainability and the Environment).

Clauses 1 to 12 inclusive agreed to.

Clause 13:

Amendments not moved pursuant to Standing Order No. 67(1):

- (1) In page 13, line 15, by leaving out "and";
- (2) In page 13, line 20, by leaving out the full-stop, and inserting "; and"; and
- (3) In page 13, after line 20, by inserting "(c) the taxable facility has been awarded allowances in no more than one of the preceding four emissions years.". (Mr Leon Perera).

Amendments proposed:

- (4) In page 13, line 26, by leaving out "specify", and inserting "ensure the award is listed on a registry that is provided free-of-charge and easily accessible to the public through electronic means, specifying";

"(3) Where the Minister permits eligible international carbon credits to be surrendered in excess of the prescribed limit pursuant to subsection (2), the decision shall be listed on a registry that is provided free-of-charge and easily accessible to the public through electronic means. The register shall contain information that includes information relating to the registered person, the emissions year where the registered person was permitted to exceed the prescribed limit for international carbon credit usage, and the Minister's reason for deciding to lift the prescribed limit.". – (Ms He Ting Ru).
